Pension Account - revaluation

Since 1 April 2014 pension built up within the LGPS is calculated under a Career Average Revalued Earnings (CARE) arrangement.

CARE benefits are revalued each year in line with a measure of inflation (currently the Consumer Price Index). Every April, LGPS active members' pension accounts are revalued in line with HM Treasury Revaluation Orders. The increase that applied from 1 April 2020 was 1.7%.

Pension Surgery appointments

As you know we offer the opportunity for face to face pension surgery events to be held at your place of work for your staff members to attend.

In light of the current social distancing restrictions in place we do not know when we will be able to resume the face to face surgery events.

We propose to run 20 minute pension consultation appointments for your staff from September 2020 onwards. We are happy to offer appointments via Microsoft Teams or over the telephone.

We would set aside a number of dates to enable your staff to book appointment times. We would ask you to communicate these dates to your staff to enable them to book an appointment directly with us.

The McCloud case - FAQs for LGPS members

The Government has confirmed there will be changes to all main public service pension schemes, including the LGPS, as a result of the Court of Appeal's ruling in the McCloud court case.

The Pension Team will be in touch in due course regarding the collection of historical changes to scheme members hours and weeks worked since 1 April 2014. It is important that scheme employers do not dispose of this information if they have not done so already.

Public Sector exit payments cap

You may recall earlier employer communications surrounding the introduction of a £95k exit cap on public sector payments.

The Government first announced plans to cap exit payments in the public sector in 2015. On 10 April 2019 HM Treasury (HMT) launched a consultation on draft regulations, guidance and directions to implement the cap. HMT published its response to the consultation on 21 July 2020.

Year-end 2020 - update

We are in the process of finalising our year-end 2020 requirements.

This year Annual Benefit Statements have been made available for scheme member's to view through their 'my pension ONLINE' as soon as their employers Year End reconciliation has been completed.

This has meant Annual Benefit Statements began being made available as early as 3 April 2020 with all being available to view by no later than 31 August 2020.

An e-mail will be sent to all employers in August to advertise the availability of the statements to view on 'my pension ONLINE'. You are welcome to then communicate this message to your staff.

2019 LGPS Annual Report

On 22 May 2020, Councillor Phillips (Chair of S A B) launched the 2019 LGPS England and Wales annual scheme report. Highlights from the report include:

- total membership increased from 5.8 million in 2018 to **5.9 million in 2019**, a rise of 0.6 percent.
- total assets **increased to £291 billion**, a change of 5.9 percent.
- local authority **returns on investment over 2018/2019 was 6.6 percent.** This was reflective of the market conditions during the year and set against the UK Return of 6.4 percent.
- the Scheme **maintained a positive cash-flow position overall**, including investment income.
- over 1.7 million pensioners were paid over the year.

What can I use ESS for?



ESS allows employers to view and amend their member data held on our pension administration system – *Altair*. ESS offers a wide range of features including:

- ✓ Create new starter pension records for your members
- ✓ Member search facility
- ✓ View and update general information (change of address, update marital status)
- ✓ Update part-time hours and weeks
- Perform benefit projections
- ✓ View member and non-member documentation
- Generate and print reports



STEP 2 - Enter your name, e-mail and employer name



Once you have submitted this information the creation of a unique Activation Key which will be e-mailed to you directly. When you have received your Activation Key please follow Step 3.
