### **Pensions Increase 2021**

Your Berkshire pension is increased annually in line with the Pensions Increase Order which is currently linked to the Consumer Prices Index (CPI). The increase is measured by the September to September adjustment in the CPI and is applied to your pension from the following April.

The 2021 increase is **0.5%** and will be applied to your pension from **Monday 12 April 2021**. The total value of your annual pension from 12 April 2021 is detailed on page three of your personalised pensions increase booklet enclosed with this newsletter.

#### Pensions increase booklet 2021

Your personalised 2021 pensions increase booklet is enclosed with this newsletter.

If your pension commenced **after 27 March 2021** you will not be due an increase to your pension this year, however your pension will increase in line with CPI from Monday 11 April 2022.



## Pension pay dates 2021/2022

Your Berkshire pension is paid into your chosen bank or building society account on the last working day of each month (your December pension is paid slightly earlier in time for Christmas). We have detailed below your pension payment dates for the next 12 months for your convenience. Please note these pay dates apply to UK bank accounts only.




### Pension payslips

A payslip will normally be issued to you if your net monthly pension payment has changed by more than 50 pence from the previous month. However you will automatically receive a payslip in April and May to reflect the pensions increase applied from April each year.

# Monthly payslip explained

A payslip is issued to you if your net monthly pension payment changes by more than 50 pence from the previous month. You will automatically receive a payslip in April and May 2021 to reflect the pensions increase applied from **12 April 2021**. Your payslip layout is explained below...



# Monthly payslip explained

- **Payments -** The elements which make up your Berkshire Pension are displayed here. *Please note:* the pensions increase figure is a cumulative total of all your pension increases from the start of your pension.
- Gross Pay This is the total pension value (before tax) due to you in the current month.
- **Deductions -** This is the total amount of tax you have had deducted from your gross pension in the current month. If the letter 'R' is displayed after the amount quoted this means you have been paid a tax refund. Any other deduction will also be shown here e.g Give As You Earn (GAYE).
- 4 Net Pay Amount of pay after deductions which will be credited to your bank account on your payment date.
- **Pension Number -**This is your pension reference number and is made up of five numbers and a letter e.g. 12345A. Please quote this reference if you contact the Berkshire pension team.
- Tax Code This will be the tax code we are currently operating for you. If M1 appears after your tax code, your tax code has been operated on an emergency basis. If you have a query on your tax code please contact the tax office directly on 0300 200 3300.
- Pay Date The date your pension credits your bank account. Normally the last working day of the month (see page five).
- 8 Year to Date These are the pay figures you have received to date within this tax year.

Don't forget you can view your monthly payment details on your online account - turn to page seventeen for more information.

## Your 2021 P60

Your P60 for the tax year 2020/2021 will be issued in advance of the HMRC deadline of 31 May 2021. We hope to post your P60 to you in April 2021.

# Your 2021 P60 explained

- Pension payroll no This is your pension reference number and is made up of five numbers and a letter e.g. 12345A. Please quote this reference if you contact the Berkshire pension team.
- 2 PAYE Reference 070/R5200 This is the tax reference number for the Berkshire Pension Fund and should be quoted if you contact HMRC. Full contact details for HMRC can be found on page eleven.
- Previous employment pay/tax deducted These two boxes will show any pay and tax from a previous employment in the same tax year as you left your previous job.
- **Pension paid -** This is the total pension you have received in the current financial year before tax is deducted.
- 5 **Tax deducted -** This is the total amount of tax you have had deducted from your pension in the current financial year.
- **Final tax code -** This is your final tax code of the year. If **M1** appears after your tax code, your tax code has been operated on an emergency basis. If you have a query on your tax code please contact the tax office directly on **0300 200 3300**.

You can view your historical P60 documents via your online account. Turn to page seventeen for more information.

Please keep your P60 in a safe place for future reference.

# Covid-19 LGPS update

The past year has been a very uncertain and difficult time for many of you. We would like to reassure you that the Berkshire pension team are doing everything we can to minimise the impact that the pandemic has had on the service we provide our scheme members and employers.

We continue to monitor Government advice and the pension team continue to work from home at this time

Alternatively you may wish to use our self-service facility – 'my pension ONLINE' to check your monthly pension payments, update your address or view your P60 documents (see page seventeen for more information).

### Will my LGPS pension value reduce as a result of the pandemic?

During these uncertain times it is understandable that a lot of our members have concerns about their pension value and how this may be affected by stock market changes due to the financial impact of Covid-19.

Your LGPS pension is guaranteed and will continue to be paid to you in full on a monthly basis and will be increased in line with the Consumer Prices Index (CPI) every April.



### Tax office contact details

If there is a change to your tax code, the tax office will issue an electronic notification to our Pension Payroll team to confirm details of the change.

If you wish to query your tax code you must contact the tax office directly. When contacting the tax office please quote the tax reference for the Berkshire Pension Fund - **070/R5200**.

#### 2021/2022 tax-free personal allowance

Most people in the UK get a personal allowance of tax-free income. This is the amount of income you can receive before you pay tax. The amount of income tax you pay in each tax year depends on:

- how much of your income is above your personal allowance
- how much of this falls within each tax band

The standard personal allowance from 6 April 2021 to 5 April 2022 increases to £12,570.

**Do you live in Scotland?** If you live in Scotland you will receive the same personal allowance for 2021/2022 as quoted above, but your tax bandwidths will be different. HMRC will determine if you are a Scottish tax payer.

Please note - the income tax you pay is calculated based on all your taxable income from all sources (including your State Pension).

## Keeping us updated

It is important that you inform us of any change to your personal details such as a change of address, marital status or change in name.

If you need to notify us of any of these changes you can do so by e-mailing info@berkshirepensions.org.uk

If you are changing your name or marital status please provide us with the accompanying certificate/documentation.

The pension team can take changes of address over the telephone, by e-mail, via our online portal or we have provided a form on

page thirteen for your convenience.

If you change your bank details we require confirmation in writing with your normal signature for security reasons. We have provided a form on

## The 'McCloud' judgement

When the LGPS changed from a Final Salary to a Career Average pension scheme in 2014, protections for older scheme members were introduced. Similar protections were provided in other public sector pension schemes.

As previously reported the Court of Appeal ruled that younger members of the Judges' and Firefighters' Pension schemes have been discriminated against because the protections did not apply to them.

The Government has confirmed that there will be changes to all main public sector schemes, including the LGPS. This ruling is often referred to as the 'McCloud judgment'.

The Government is still considering exactly what changes need to be made to remove the discrimination from the LGPS. If you qualify for protection it will apply automatically (even if you are retired) - you do not need to make a claim.

#### **Pension Scams awareness**

Although it is not possible to transfer your pension to another pension provider because it is in payment to you, the Pension Fund has a duty of care to make sure you are aware of pension scams that often can be hard to spot.

Scammers can be articulate and financially knowledgeable, with credible websites, testimonials and materials. Scam tactics include:

- · Contact out of the blue
- Promises of high/guaranteed returns
- Free pension reviews
- Access to your pension before age 55
- Pressure to act quickly

Scammers design attractive offers to persuade you to transfer your pension pot to them (or to release funds from it). It is often then invested in unusual and high-risk investments like overseas property, renewable energy bonds, forestry, storage units, or simply stolen outright.


## Quick Q&A

Can I request a duplicate P60? P60 documents relating to previous years can be found in the 'Payroll' section of your online account. Alternatively you can contact the pension team to request the details you require.

I require a relative to act on my behalf concerning my financial affairs - what information do you need? If your representative holds Power of Attorney we will require sight of this document to hold on our records (scanned/ photocopies are acceptable).

If a Power of Attorney is not in place you can instead write to us to provide contact details of your chosen representative.

I am moving abroad. Can I have my pension paid overseas and is there a charge for this? If you live abroad you can request to have your monthly pension paid into an account in the country of your residence.



If you choose to have your pension paid via OPS, your pension will be credited to your personal bank account in your local currency. However, please note that not all countries are able to offer the OPS facility.

All administration charges for this service will be met by the Royal County of Berkshire Pension Fund.

Can I have my pension paid weekly, quarterly or annually? Unfortunately we are unable to change the frequency of your pension payments. Pensions are paid on the last working day of every month (with the exception of December when your payday is slightly earlier in time for Christmas).

## Take control of your pension

#### 'my pension ONLINE'

is an internet based application which enables you to securely access and update your own pension details online via the Royal



County of Berkshire Pension Fund website from the comfort of your own home or workplace using a desktop PC, laptop, smartphone or tablet

As a **Retired** or **Dependant** member of the scheme you can:

- View your personal details
- Change your address
- View your P60 and payment history
- Access all publications
- Calculate the value of your dependant benefits

### Upload your documents online

Did you know you can upload documents to your own pension record? Rather than sending us forms in the post or e-mailing us you can upload documents securely via 'my pension ONLINE' so that they appear on your pension record.

This is particularly useful if you need to send paperwork to us, such as a change in marital status or change of name.

The 'Document upload' facility can be found in the 'Documents' section of your online account.
